NOTES: On Election Night, a total of 24 districts did not report results, including some in Oswego, Madison, and Oneida counties. In Oneida County, these must have been Lee's 2nd and 5th districts, as the sum total of the other districts in the spreadsheet match the countywide totals reported in the Watertown Daily Times. Why these districts did not report their results is unknown to me.

The numbers from Camden's 2nd district, where Hoffman got only 12 votes, or 9% of the total, are clearly wrong. I do not know if these numbers have been corrected. Elsewhere in the county, the most anomalous precincts are Annsville's 2nd and 3rd districts, where Owens' vote count was 44% and 27%, respectively, in neighboring precincts, which is not impossible.
