- o Overall progress of testing:
 - NYSTEC & SBOE have continued to meet, consistent with the schedule for the final stages of certification tasks required so that at the December 15th Board Meeting the Commissioners have all the information they need to vote on certification.
 - SBOE hosted multi-day meetings with both Dominion and ES&S to discuss the testing reports. NYSTEC and SysTest attended the meetings as well.
 - SBOE will be meeting with CEMAC, NYSTEC and Systest on December 7th to review the various testing documents and reports.
 - NYSTEC met with SBOE to discuss its draft report on compensating controls and summary report on the testing effort.

TESTIMONY BEFORE THE NEW YORK STATE SENATE COMMITTEE ON ELECTIONS

ROBERT A. BREHM Co-Executive Director, New York State Board of Elections November 30, 2009

New York committed itself to full testing of each voting system before certifying compliance with the federal Voluntary Voting System Guidelines (VVSG). Although New York has encountered delays in bringing new, fully compliant voting systems into use, we have had our commitment to our groundbreaking testing initiatives reaffirmed, as those delays uncovered major flaws in the certification testing process previously used by the national certification authorities. New York's exposure of the inadequacies of the old process has led to major reforms at the Election Assistance Commission. Indeed, New York should be proud that its standards have become the gold standard for certification testing. Both ES&S and Dominion Voting Systems, the two companies that have submitted voting systems for certification to New York's high standards deserve praise for their commitment to the process, and the recognition that if they obtain certification from New York, they will have met the highest industry standards that will enhance their ability to market their systems nationally and internationally.

The certification process is almost complete, and we anticipate that the State Board will be certifying the ES&S DS-200 and the Dominion ImageCast precinct based voting systems in December. We are advised that to date, there are no "showstopper" issues, and we remain committed to full compliance with

the standards, as provided in our contracts with the vendors. On the other hand, if we do identify a problem in the testing that remains outstanding, we will still insist on the modifications necessary to achieve compliance with the New York State regulations and the VVSG.

The Pilot Project

The State Board of Elections concluded that there would be substantial advantages using the new voting systems in selected jurisdictions as a pilot project. In recognition that we are using equipment that is not fully certified, the State Board imposed additional security and verification procedures in order to assure the accuracy of the results.

Forty-six counties opted to participate in a 2009 pilot project. Thirteen of those counties did not have primaries, leaving thirty-four counties in the Primary Pilot Project. All machines used were subject to functional testing to validate the logic and accuracy of the systems, and each machine was subject to thorough acceptance testing. As a further safeguard the State Board required:

- Full compliance with the audit provisions contained in Election Law §9-211 and the audit provisions contained in the proposed regulation 6210.18.
- Conduct a 100% hand audit of all ballots in election districts when the
 difference in the result of the election between the potential winning and
 losing candidates in any contested election on the ballots is 1% or less
 AND,
- Randomly select 3 % from all the devices used in each county, or, borough within NYC, and hand audit all of the ballots tabulated by that device. If the outcome does not match the canvass report, then a 100% hand audit is to be conducted.

We are happy to report that the Pilot Project for the 2009 General Election successfully accomplished our goals of introducing the new voting systems and identifying election administration issues that will require greater attention both for our county boards of elections and the State Board.

As was reported to the Commissioners of the State Board of Elections at their meeting on November 10, 2009, the General Election Pilot Project successfully accomplished our goals of introducing the new voting systems and identifying election administration issues that will require greater attention both for our county boards of elections and the State Board. While not without a few

incidents, perfection was not expected, as the Election Day optical scan technology was new to voters across New York, and to County Boards of Elections. We are grateful to the County Boards of Elections which opted to participate in the Pilot Project, and in particular to those Boards which opted for a county-wide pilot deployment.

State Board of Elections staff teams observed Election Day observations in eighteen General Election Pilot Counties and during the Primary Election, seventeen Primary Election Pilot Counties were visited.

There is still room for improvement, however it is important to note that Boards which fully embraced the challenge of this pilot and the use of this technology, experienced a greater level of success in the conduct and administration of the election as well as in the ease of use and positive feedback of their voters. It is key that voters, candidates, advocates, stakeholders and others understand that the optical scanners which were used in this pilot project, and which will be used in all future elections, offer a level of security that has never been possible with lever machines – regardless of any number of election day scenarios, Boards of Elections will always have the ballots which voters marked, thus ensuring that elections are recoverable and every vote will be accurately cast and counted.

In addition two scenarios merit explanation. For Dominion systems, the pre-election testing conducted by the Franklin County Board of Elections revealed an anomaly in the system's software, which manifested itself when certain potential voting patterns appeared in certain multiple vote-for candidate voting positions. In such instances, the system 'froze', making it impossible to scan subsequent ballots. The vendor was contacted, and it was determined that the issue was related to the memory required to store images of scanned ballots. Prior to Election Day, the vendor reviewed all ballot styles for all of its customers, made a configurable file change to eliminate this problem in the pilot project and pre-election testing was completed on all systems prior to their use on election day. Also, Dominion corrected the software submission they had delivered for New York's voting system certification effort.

Unfortunately, in that the review of ballot styles to pinpoint where the problem might manifest itself was a human review, some of the ballots styles were mistakenly tagged as acceptable. The problem did occur on Election Day, and in those instances, voters proceeded to vote on emergency ballots, which were ultimately either scanned in an alternate, replacement scanner, or were

hand-counted according to existing county board of elections emergency procedures.

For ES&S, a programming issue made by the Erie County Board of Elections was not discovered until Election Day, which resulted in certain candidates in a multiple vote-for contest not aggregating all of their results. On Election Day, in the affected districts, voting continued on emergency ballots which were scanned on the day after the election, using corrected ballot configurations. It was determined that the problem was evident in the pre-election test results, however as humans were reviewing the test results, the anomaly of votes not being aggregated correctly was missed in the review and validation of pre-election test results.

The lessons learned from this Pilot Project are valuable ones, and will be included in the Board's final General Election Pilot Test report which will soon be completed. As the use of these systems becomes more prevalent, the ease with which Election Day workers and voters use them will increase. Frequency of use will nurture confidence and expertise. The State Board will review outstanding issues with each specific Board of Elections, and will take steps to ensure that all procedures and corresponding forms are reviewed, with an eye towards reflecting real-world usage suggestions collected by Election Operations staff. A preliminary list of the observations includes:

- 1. Boards must review each poll site, and draw floor plans for the optimum placement of scanners and privacy booths, to better ensure as much privacy as possible for the marking and scanning of ballots. Drawings and/or photos showing inspectors the proper placement of all Election Day work stations should be reviewed in training sessions, and provided to inspectors with their Election Day supplies. If current poll sites cannot accommodate new equipment in a manner that affords voters privacy, comfort and safety, alternate poll sites should be identified.
- 2. As is evidenced by the photos and comments contained in this report, Boards and inspectors need to make consistent use of privacy hoods vendors make available for affixing to the scanner itself. Further, election inspectors must offer privacy sleeves to each voter with their respective ballot, thus allowing the voter the option of using the sleeve when accessing the scanner to cast their ballot.
- 3. The conduct of pre-election testing is critically important, as is the validation of the results of that testing. The State's testing requirements are extensive, and the preparation for and conduct of the testing does take a fair amount of time, but

the issues it can uncover will help ensure that County Boards can recover from situations in a timely and more responsible manner, and do so before Election Day.

- 4. County Boards of Elections are urged to review the number of spare scanners they have purchased to date, and **consider acquiring additional units**, in a number sufficient to ensure that Boards can put such units into poll sites on Election Day, to better serve voters and poll sites when problems arise, or a particular election season's higher turnout warrants the deployment of more units.
- 5. Hands-on training for all election day workers is essential, so that a full array of voter services is available throughout election day. Boards can certainly train some election day staff as specialists in the delivery of various tasks related to services, however each person working in a poll site should be able to provide assistance to voters at every juncture of the voting experience.
- 6. The return of voted ballots and memory cards to Boards of Elections after the close of polls is a critical security requirement that cannot be diminished. Boards should explore every option available to them for the return of these key items, including centralized pick-up of security bags; the assistance of law enforcement officials, voting equipment technicians, custodians and other voting system facility staff in collecting and delivering security bags; reconsidering and re-prioritizing close-of-polls tasks, so that inspectors can complete essential tasks and return security bags as quickly as possible.
- 7. County Boards of Elections must be more diligent in the creation of informational notices sent to candidates and others, as required by statute. Samples of these notices have been provided in the past, and will be reviewed again, so that the best of them can become models for all Boards to adopt. This concept is consistent with our inclusion of 'Best Practices' in the procedures we have delivered to Boards thus far, and those yet to come.
- 8. Boards must arrange for extensive training in their respective vendor's Election Management System, so that Board staff members charged with this responsibility can become much more adept at building ballots, and where possible, increasing font size, to better address voter concerns for the legibility of ballot information. The State Board can serve as a resource in this area, and stands ready to assist, once Boards have completed their vendor's EMS training program.

Additional Legislation

Now that it is clear that all New York jurisdictions will be using poll site based ballot scanning, it has become apparent that there are significant revisions to New York's rules governing poll sites, election districts and election staffing that would better take advantage of the features of the new scanning systems.

The law currently provides for the division of each town or city into election districts. Election Law 4-100 contains strict rules for the formation of election districts that were based on the features of lever voting machines and the need to have all voters in the election district voting on the same ballot style form. Particularly in densely populated urban and suburban areas, it is not unusual to locate multiple election districts at the same poll site.

Scanners allow the use of multiple ballot styles. Therefore, it is no longer necessary that all of the voters have the same ballot form (although it is essential that election officials give each voter the correct ballot form). Most other states, therefore, do not restrict the number of voters at a voting precinct and organize each poll site to accommodate the number of voters at that site.

New York's current law that provides for four inspectors assigned to each election district at a poll site is inefficient. Instead, New York should look to the model in other states and should appoint and organize election workers based on the *poll site* not on the *election district*. The Election Commissioners Association of the State of New York has been considering proposals to address this issue, and I urge that the Election Committees of the Senate and Assembly also focus on this issue—which could lead to substantial economies for the counties, and the more efficient operation of poll sites.

Lever Voting Machines

New York enacted the Election Reform and Modernization Act of 2005. (L. 2005, c. 181 amended L.2007, c. 506.) Section 11 of the law prohibits the use of lever voting machines once the State Board of Elections certifies precinct based ballot scanners or direct recording electronic machines that comply with Election Law § 7-202.

Section 301(a) of the federal Help America Vote Act sets forth minimal standards for all voting systems used in federal elections. The Federal Election Commission issued an advisory opinion, No. 5 of 2005, that concluded that lever voting machines failed to meet four standards contained in HAVA § 301(a).

- Audit Capacity (HAVA §301(a)(2)(B)(i)) "produce a permanent paper record with a manual audit capacity..." for use in a recount.
- Error Rate (HAVA §301(a)(5)) requires that all voting systems have a test error rate that complies with error rate requirements of §3.2.1 of the VVSG.
- Alternative Language Accessibility (HAVA §301(a)) requires voting systems provide alternative language accessibility pursuant to the requirements of the Voting Rights Act of 1965 (42 U.S.C. §1973aa-1a).
- Accessibility for Individuals with Disabilities (HAVA §301(a)) at a minimum, election officials must provide at least one voting system equipped for individuals with disabilities at each polling place. Such system must provide voters with disabilities the same opportunity for access (including privacy and independence) as other voters.

The United States Department of Justice brought suit against the State of New York to compel replacement of the lever voting machines in order to comply with the Help America Vote Act. The federal court entered an order on June 2, 2006 that required New York to replace all lever voting systems with HAVA-compliant voting systems. New York State also applied for and accepted nearly \$50 million in federal funds pursuant to Title 1 of HAVA appropriated solely for the purpose of replacing lever voting systems. (New York has also received an additional \$158 million in non-earmarked HAVA funds that are available for new voting systems.)

The Attorney General's office and our own legal staff have repeatedly advised us that there is no way for New York to retain its lever voting machines without an amendment to the Help America Vote Act. Many people have discussed such an amendment with members of our Congressional delegation, but no one has introduced such a bill, and there is virtually no chance of enacting such legislation.

New York State is under court order to replace our lever voting machines. New York has adopted some of the most progressive regulations in the nation to insure the integrity of the new voting systems. Our certification testing system is the most comprehensive in the nation and has become the model for other states.

We simply do not have the option to retain lever voting machines. The movement to retain them is misdirected because it cannot succeed without an act of Congress. Instead, the efforts of advocates of retaining lever machines would be much more productive if they were directed to insuring the best possible procedures for transparent, accurate and verifiable use of the new machines in each county.

Vote Recount in Nassau Executive Race Ends

Edward P. Mangano, the Republican challenger for Nassau County executive, expanded his lead over the Democratic incumbent, Thomas R. Suozzi, as the vote recount in the race concluded on Monday.

With the last paper ballots counted, Mr. Mangano, a county legislator, held a 390-vote lead out of the nearly 250,000 ballots cast on Election Day. Although Mr. Suozzi led by 237 votes on

Nov. 3, Mr. Mangano was ahead by 217 votes by the end of last week.

Despite Mr. Mangano's lead, the results will not be certified until lawyers for both candidates appear Wednesday in State Supreme Court in Mineola. Justice Edward W. McCarty III is expected to rule on which contested ballots will be counted. Objections to 700 to 800 ballots have been filed, elections officials said.

Steven R. Schlesinger, a lawyer for Mr. Suozzi, said he and his client would meet Tuesday to discuss which ballot challenges if any they wish to pursue.

But John Ciampoli, a lawyer for Mr. Mangano, said he believed that Mr. Mangano's lead was large enough to ensure that none of the contested ballots would change the outcome. He also said there was insufficient grounds to conduct a new election.

Mr. Mangano stayed at the County Board of Elections recount room all day Monday. "I've been ahead the whole time day ing the recount, and I expect to be ahead at the conclusion," he said by phone Monday night.
